## Personal Legal Fees

## **Moving violations**

Participation in the Open Road Drivers Plan entitles you to assistance with legal fees, win or lose, for any moving violation.

## Non-moving violations

Open Road Drivers Plan members are entitled to legal fee assistance, win or lose, for your defense against non-moving violations. The plan will cover seatbelt and parking violations when they affect your CDL. Other non-moving violations may include alleged overweight, overwidth, overheight, or overlength citations.

# \$5,000 - Manslaughter, negligent homicide, vehicular homicide
