Open Road Drivers Plan (ORDP), a division of Multi Service Corporation (MSC), agrees to provide plan benefits to all drivers and owner/operators actively enrolled as represented through Company. Participants' plan fees will be payroll or settlement deducted by Company and remitted to ORDP.

ORDP will not provide referrals or legal fees assistance for any legal action against participant's Company or employer. MSC and ORDP will hold Company harmless and defend same against any legal actions taken by drivers and/or owner/operators, as related to ORDP coverage.

ORDP agrees to provide plan benefits to all participants submitting deductions until driver and/or owner/operator terminates employment or owner/operator relationship with Company, or driver cancels the program in writing to ORDP. Company agrees to notify ORDP of any changes affecting the offering of this program with thirty days written notice.

ORDP representative(s) will present the plan to drivers and owner/operators during orientation classes, safety meetings and at terminals. Company may accept ORDP applications directly from drivers, unless otherwise restricted by state law. ORDP will be the sole provider of trucking motor club or legal service to Company's drivers and owner/operators.

MSC will submit an administrative fee of \$2.00 for each ORDP participant each month to Company. Company will receive administrative fees monthly based upon previous months enrollment, in consideration of timely remittance of plan fees by Company and access to drivers and owner/operators. Plan benefit coverage is contingent upon timely remittance of plan fees.
